### **Official Minutes**

### March 20, 2014

Betty Greiner presented the year end position for 2013. As of December 31, 2013, receipts totaled \$15,419,634.41 and payments were made of \$16,987,453.54. The end of the year bank balance was \$6,897,910.67. The financial statements were then presented as of March 19, 2014. Receipts as of March 19, 2014 were \$2,813,413.17 and expenditures were \$1,250,009.41, resulting in an ending cash balance of \$8,461,314.43.

A reimbursement request was made by Betty Greiner for Shawnee County in the amount of \$1,500,000 for County Bridge projects as stated in the interlocal agreement.
