### **Meeting Minutes**

September 28, 2006 meeting minutes – Amended with the following correction:

Marti Lynn handed out a memo given to her him from Richard Eckert, Shawnee County Counselor, regarding the Kansas Open Meetings Act (KOMA) outlining that JEDO Finance Committee is subject to KOMA under K.S.A. 1979 Supp. 75-4318(a).

#### **Disbursements**

County Project No. 70003-03, Phase IIIA, Request for the disbursement of Sales Tax Funds in the amount of \$80,000.00 which provides for the purchase of necessary traffic signal equipment and electronics for the intersection improvement project at SE 29<sup>th</sup> and Croco Road – Motion to approve, seconded, and Motion carried unanimously (4-0).

County Project No. 70003-01, Phase IA, Request for the disbursement of Sales Tax Funds in the amount of \$147,000.00 for the final plans and bidding documents to improve SE Croco Road between SE 29<sup>th</sup> Street and SE 21<sup>st</sup> Street - Motion to approve, seconded, and Motion carried unanimously (4-0).

#### **Project Approvals**

County Project No. 70003-03, Phase III, to improve the intersection at SE 29<sup>th</sup> and Croco Road - \$3,405,000.00 - Motion to approve, seconded, and Motion carried unanimously (4-0). Discussion was made to transfer portion in three months, then another portion in three months. Will go to Board of County Commissioners bid on 11-15-06 and will need the money available shortly thereafter.

Revised Budget for 53<sup>rd</sup> & Wanamaker, County Project No. 70001-02. The bid amount of \$3,009,071.00 is an increase of \$35,237.00 from the budget approved on 3/20/06. The revised budget reflects increases in construction costs, County local match, design fees, right-of-way costs and utility relocation costs. Increases funding from county-wide sales tax by \$103,201.00 - Motion to approve, seconded, and Motion carried unanimously (4-0).
